# **Summary Report of Public Meeting #1** April 20, 2019

Through the generosity of the St. David's Foundation, Austin Parks Foundation is managing the playground replacement and construction of additional fitness options at Quail Creek Neighborhood Park. With support from the City of Austin Parks and Recreation Department, this project will include new play equipment and replacement safety surfacing. Updated fitness equipment will provide healthy exercise options for the community.

The first public engagement was held on Saturday, April 20 at the North Austin YMCA at 1000 West Rundberg Lane. The engagement featured informational graphic boards along with activity boards that allowed the public to vote on preferred amenities and amenity locations.

#### **Activities: Pick your Amenities**

Meeting attendees were provided with a large activity board categorizing play structures for ages 2-5 and 5-12, swing options, extra play options, and fitness equipment options. Participants were given stickers to vote for their favorite amenities in each category




#### **Online Survey Results**

An online survey was opened for one month after the meeting for attendants to fill out. Through the survey, we were able to collect information about which playground layout and amenities the community prefers along with comments and concerns about development of the new playground.

Twenty-two (22) participants provided responses.



Of the respondents, sixty-four (64) percent have children of the following age ranges:



Some of the hopes expressed about the development of the playground included:

- 2. More swings
- 3. Good lighting
- 4. Fitness center in close proximity to the playground for parents
- 5. Continuous fencing
